- In the third quarter of 2018, California grew at an annual rate of 3.5%, which was faster than the overall US growth rate of 3.4%. California's 2017 growth rate of 3.0% was down from the 2016 rate of 3.1% (Source: BEA) • In February 2019, the unemployment rate was 4.2%, down from 4.3% in February 2018...
