WHEN TO USE A LEASE, LICENSE, EASEMENT

LICENSE A license gives the permission of the owner to an individual or an entity to use real property for a specific purpose Unlike a lease, it does not transfer an interest in the real property It is personal to the licensee and any attempt to transfer the license terminates it It is (usually) revocable and can be either exclusive or non-
