Employment Act (ADEA)(1) (29 USC § 621) Protects people who are 40 or older from discrimination because of age The law also makes it illegal to retaliate against a person because the person complained about discrimination, ~led a charge of discrimination, or participated in an employment discrimination investigation or lawsuit
