### **Two Additional Homestead Exemptions for Persons 65 and ...**

- An exemption equal to the assessed value of the property to an owner who has title to real estate in Florida with a just value less than \$250,000, as determined in the first tax year that the owner applies and is eligible for the exemption, and who has maintained permanent residence

1 In Writing: The Statute of Frauds requires that contracts for the sale of real property in Florida must be in writing (There is an exception for oral contracts that have been partially performed, but the exception rarely arises) Witnesses are not required 2

**Q: What is portability?**

No, the law requires the previous homestead to be abandoned. In other words, the homestead and Save Our Homes benefit must be removed. The owner who remained on the previous property can give up the homestead, re-apply for it and "port back" half of the Save Our Homes benefit, but that means the taxes will go up on that property.
