Documentary - an obligation by the issuing bank to pay the agreed amount to the beneficiary (usually the seller) on behalf of the applicant (buyer) upon receipt of the specified documents Standby - this operates more like a demand guarantee It is a secondary rather than a primary obligation to pay, usually triggered by non-performance
