–Qualifying Venture Capital Funds The Final Amendments also include a new exclusion for venture capital funds, as defined in Rule 203(l)-1 under the Investment Advisers Act, largely as proposed Under Investment Advisers Act Rule 203(l)-1, the term “venture capital fund” includes any private fund that:
