Employment Rights for Working Parents

Your employer might simply agree to your request to work flexibly If your employer does, then they should write to you within 28 days setting out the agreed changes to your employment contract and the date on which the new working pattern will start If your employer does not agree with your request they should also have a meeting with you

DOCTORS' AND PATIENTS' RIGHTS AND RESPONSIBILITIES

All rights may be limited by a law of general application This law has to be reasonable and justifiable in a democratic society and conform to the requirements set by section 36 of the South African Constitution The Association recognise that it will not participate in the unlawful limitation of the rights of any person or organisation and

SUMMARY OF POWERS AND DUTIES OF TRUSTEES

Indiana law provides a detailed description of powers available to a Trustee but states that such powers apply “unless the terms of the trust provide otherwise” Therefore, a Trustee should first determine which powers are included, or excluded, by the trust agreement before determining what other powers may be granted him under the Trust Code
